



## **NBSC Privacy Policy**

### **Purpose**

The North Bay Skating Club (NBSC) respects and protects your privacy. This means that:

- NBSC will not sell, exchange, loan or make available to other organizations any personal information that you have provided to us;
- NBSC will keep all personal information confidential and will have safeguards to protect that information whether in print, electronic or other form; and
- NBSC will make available to you, upon request, your personal information that is on file and will correct, amend or delete information at your request unless otherwise required by law.

### **Personal Information and Purpose of Collection**

The Personal Information Protection and Electronic Documents Act (PIPEDA) governs privacy of information.

Personal information is the information that relates to you as an identifiable individual. Personal information does not include business information (e.g. an individual's business address and telephone number).

NBSC will only collect personal information to meet and maintain the highest standard of organizing and programming in the sport of skating. NBSC collects personal information from participants, coaches, officials, team managers, contractors, employees and volunteers (collectively "Individuals") for purposes that include, but are not limited to, the following:

- a) Registration for programs, activities, and events; and purchasing equipment and other products.
- b) Receiving communications from NBSC in regard to fundraising, programs, events, and activities.
- c) Determining eligibility, age group and appropriate level of play/competition.
- d) Award nominations, biographies, published articles and media relations.
- e) Data to determine level of certification, coaching qualifications, and coach selection.
- f) Credit card information for purchasing products and for registration at events and activities.
- g) Names, ages, and signatures for the purpose of participant agreements, permission where medical treatment is concerned, and collection of waivers.
- h) NBSC's payroll, contractual obligations, bursaries, grants and honorariums.
- i) Name and contact information for the purpose of communication within and between the board, committees, volunteers, members, etc.



- j) Club/skating school and section contact information: such as club/skating school and section name, web address, contact person(s) name, phone number and email address for the purpose of relaying and collecting information relating to the activities of NBSC.
- k) Emergency contacts, medical history for use in the case of classification, medical emergency or reports relating to medical or emergency issues and managing insurance claims.
- l) Determining membership demographic structure, and program wants and needs. Information as required by the NBSC General Dispute and Resolution Policy.

## **Consent**

- a) Consent is required to be obtained by lawful means from individuals at the time of collection, prior to the use and disclosure of the personal information. If the consent to the collection, use or disclosure was not obtained upon receipt of the information, consent will be obtained prior to the use or disclosure of that information.
- b) NBSC may collect personal information without consent where reasonable to do so from the perspective of the individual whose information is at stake, and where permitted by law.
- c) By providing personal information to NBSC, individuals are consenting to the use of information for the purposes identified in this Privacy Policy.
- d) In determining the form of consent to be obtained, NBSC will take into account the sensitivity of the information.
- e) NBSC will not, as a condition of a product or service, require an individual to consent to the collection, use and disclosure of information beyond that required to fulfill the specified purpose.
- f) An individual may withdraw consent to the collection, use or disclosure of personal information at any time, subject to legal or contractual restrictions, provided that the individual gives one week of notice of such withdrawal to NBSC. The NBSC Board of Directors, will advise the individual of the implications of such a withdrawal.

## **Limited Collection, Use, Disclosure and Retention**

- a) All personal information will be collected fairly, by lawful means and for the purposes as specified in this Privacy Policy,
- b) Personal information will not be used or disclosed by NBSC for purposes other than those for which it was collected as described herein, except with the consent of the individual or as required by law.
- c) Information may be forwarded to volunteers of the organization (such as Committee Members, Board of Directors, Local Organizing Committees, Competition Officials), other associations for the purpose of clinics, programming, and competition, Skate Ontario, Skate Canada, Coaches Association of Ontario, Award organizations, ministries of the provincial and/or federal government or other parties with whom NBSC deals.
- d) Information disclosed to a third party with consent from the individual shall be protected by a third-party agreement to limit use and disclosure.
- e) Personal information will be retained for certain periods of time in accordance with the



following:

- i. Program registration data and athlete information will be retained indefinitely for the sake of historical record and tracking purposes.
- ii. Registration data for programs, clinics, camps, and competitions may be retained indefinitely after the event for record purposes.
- iii. Employee information will be retained for a period of seven years in accordance with Canada Customs and Revenue Canada requirements.
- iv. Personal health information will be immediately destroyed when an individual chooses to leave a NBSC program.
- v. Marketing information will be immediately destroyed upon compilation and analysis of collected information.
- vi. Credit card information will be destroyed immediately upon completion of a financial transaction.
- vii. As otherwise may be stipulated in federal or provincial legislation.

## **Employee Commitment**

Our employees, contractors and volunteers are committed to respecting the personal information we hold in our files. Our employees have been trained on the appropriate use of personal information.

Volunteers, coaches etc. who receive personal information in order to carry out the work of the organization will be notified with regards to the safekeeping of such information.

## **Accuracy**

NBSC will use accurate and up-to-date information as is necessary for the purposes for which it is to be used, to minimize the possibility that inappropriate information may be used to make a decision about an individual.

## **Security**

All information held by NBSC is subject to strict internal security to prevent unauthorized access and improper usage. Electronic records are subject to limited access by authorized personnel who must use passwords and other security measures. Print records containing personal information are subject to physical protection such as locked rooms or cabinets, accessible only to authorized personnel.

## **Website**

When you visit the NBSC website, ([www.nbfsc.uplifterinc.com](http://www.nbfsc.uplifterinc.com)) steps will be taken to respect and protect your privacy. NBSC automatically collects generic, non-personal information about visits to our website. NBSC does not collect personal information such as names, ages, phone numbers, addresses or email addresses from visitors to our website.



NBSC does collect selected visitor information such as IP addresses, return visits from past guests, referring pages, pages visited, and time spent on the website. This non-personally identifiable information is collected in order to obtain statistical analysis of website traffic patterns, administer our website and servers and improve our services. NBSC will collect data in aggregate form and data is not recorded or stored about individual visitors.

Cookies are small text files that a web browser transfers to and from your hard drive for record keeping purposes. The use of cookies is an Internet standard. NBSC does use cookies to serve you better. However, cookies are not used to retrieve personal data from your hard drive or to obtain your email address or other personal information. A cookie is information about how and when you use a website, and it is created at the time you visit a website. Rather than retain this data, SO's cookie is a small text file sent to your computer hard drive to record your preference information on your own computer. Most of SO's cookies are "session cookies" used only for the time you stay on the website each visit.

If you do not wish to accept cookies, you may choose not to by setting your browser options to inform you when cookies are being sent or to deny cookies altogether. Please note, however, that by not accepting cookies, you may limit the functionality that we can provide to you when you visit our site.

The NBSC website is a product of NBSC. The information on the website is provided as a resource to those interested in skating in North Bay. NBSC disclaims any representation or warranty, express, or implied, concerning the accuracy, completeness, or fitness for a particular purpose of the information. Persons accessing this information assume full responsibility for the use of the information and understand and agree that NBSC is not liable for any claim, loss or damage arising from the use of this information.
